#### **Guests:**

Library Representative – Jane Cybulski informs the board Peggy Hemmerling is retiring. The library board voted to appoint David Ettleman for Director. They also voted to use the year end solicitation to fundraise for automated restroom doors. As of the end of their fiscal year, June 30, the library had 81,753 visitors and 58,507 the previous year. The program attendance was 9,705 attendees and 7,500 for the previous year. Hall asks about the windows, small defect was found from manufacturer, testing is being done.

Bellmore inquires about the marihuana license expiration dates, Hawthorne one has current licensing but the one year date is likely approaching.

### Commissioners Report:

Commissioner Dave Jackson has news from the County that spongey moth survey will be starting at the end of the month and into October, receive results hopefully by year end. Micheal Brown retired at the end of August and replaced by Eric Zuzga. The solar ordinance is completed, there will be a Public Hearing for Planning and Zoning review on the 23<sup>rd</sup> at 7pm at the Tyden Center. The term for County Commissioner is now 4 years. The EDA says there are BEAD grants require 50% matching funds and it would cost about \$20 million to complete the county broadband connection. There are three companies applying to take care of all of Barry County.

Watson compliments on choosing the new airport manager, Gino Lucci.

Proposal to extend and create a new Urban Services District 4.

Pat Sharpe says the previous treatments are good, the assessments will stay the same. Jamie Degares from PLM says there was success in reducing exotic species, macro algae and phosphorus removed from inlets.
